Dear Participant:

This is a reminder that as of September 1, 2013, the Plan will no longer be utilizing the services of Blue Cross Blue Shield of Michigan (BCBSM) for your medical or prescription services.

As of **SEPTEMBER 1, 2013** the Plan has new providers for your prescription benefits: **Humana** and medical benefits: **Anthem**, with claims being processed through **Benesys**.

**PLEASE NOTE: *Your deductible, co-payments and out-of-pocket maximums have not changed***

## **Prescription Drug Program and Pharmacy Benefit Manager - HUMANA**

**Humana** has over 62,000 in-network pharmacies nationwide including large chains to small privately owned facilities. **Humana** also owns its own mail order pharmacy, RightSource Rx that is listed as the third largest mail order facility nationally that will handle your mail order prescription coverage. For questions regarding your pharmacy benefits, contact **Humana** toll free (877) 823-2386. **Please note: your prescription co-payments have not changed.**

If you currently obtain your prescriptions via mail order and wish to continue with mail order, you must call **Humana's** mail order department, RightSource RX to change your mail order prescription vendor. Contact **Humana** at the telephone number listed on the back of your Prescription Card; toll free (877) 823-2386 and select option 3 for the mail order department.

**Humana** Pharmacy Cards were mailed to all eligible participants – if you have not received your **Humana** Pharmacy Card, contact the Fund Office (877) 244-9473 to verify your eligibility.

On your next visit to the pharmacy, be sure to update your pharmacy records by showing your new **Humana** Pharmacy Card.

## **Preferred Provider Network - ANTHEM**

Effective September 1, 2013 BCBSM the Funds Preferred Provider Organization (PPO) network is **Anthem** and all medical claims will be priced through **Anthem** and/or the **BlueCard** program.

In addition, your claims will be processed through **BeneSys**. **BeneSys** is a Third Party Administrator that will process all of the claims for the Fund with the **Anthem / Blue Card** discount. If you have any questions regarding the processing of your medical claims, please contact **BeneSys** toll free at (855) 337-9346. **Please note: your deductible, co-payments and out-of-pocket maximums have not changed.**

New **Anthem** identification cards were mailed to all eligible participants – if you have not received your **Anthem** ID card, contact the Fund Office (877) 244-9473 to verify your eligibility.

To find a participating provider, contact the Provider Locator number (800) 810- BLUE (2583), or visit the Blue Cross website; [www.bcbs.com](http://www.bcbs.com).

On your next visit to the Doctor, hospital or laboratory, etc., update your insurance information by showing your new **Anthem** ID card.

The Fund Office (TIC International Corporation) will continue to process contributions, calculate eligibility, process self-payments, disability benefit claims and Supplemental Benefit Account (SBA) claims. In addition, the Fund Office will continue to process the Money Purchase Plan and Pension Fund benefits.
